Sealed quotations are herewith invited by SJVN Arun-3 Power Development Company Pvt. Ltd. TERMS & CONDITIONS (T&C):

1. Eligible Bidders

- This Invitation for Bid is open to all the bidders registered in Nepal who meet the Qualification Criteria as defined hereunder.
- Bidders should not have as an individual or as a partner in JV banned/ de-listed/ black-listed/ debarred from business by any PSU/Govt. Deptt. /SAPDC during the last 03 (three) years on grounds of corrupt/fraudulent practices and/or on any ground. An undertaking to this effect shall be furnished by the bidder as per the format attached Annexure-‘F’.

2. Minimum Qualifying Requirements:

- Average Annual Financial turnover during the last 3 years, ending 15th July, 2025 should be at least **NPR 3,00,129/-**.
- Bidder/Supplier should be registered in Nepal for the relevant category of business (i.e. registered for the business of Supply and Repair/Maintenance of Electrical/Electronic equipment/items).

3. Submission of Bid: -

The bidder must submit the bid in the following **two separate sealed envelopes {PART-I (Envelope-1) & PART-II (Envelope-2)}** clearly indicating the contents therein duly super scribed as under and these two envelopes should be enclosed in a single

sealed envelope/cover super scribed as **“Rate Contract for Schedule Servicing and Maintenance work along with spares parts under AMC of Air Conditioners (ACs) installed at SAPDC Office Complex in Tumlingtar, Power House Pukhuwa, Dam Site Phaksinda, Site Office Janakpur and Dhalkebar of Arun-3 HEP, Nepal for a period of 02 years. (PPR-219/2025)”** and submitted at the address of the undersigned (Satluj Bhawan, Arun Sadan, SAPDC, Tumlingtar, Distt. Sankhuwasabha, Nepal) and must reach this office through courier or by post or by hand on or before **by 11.12.2025 1530 Hrs.** and same shall be opened on **11.12.2025 at 1630 Hrs.** in presence of authorized representative of firms who choose to attend.

Further, In the “Techno-Commercial” part *{i.e. in PART-I (Envelope-1)}* of the bid the bidder shall not give any indication about the bid price in any manner whatsoever. Non-compliance of this provision may result in the rejection of bid.

PART-I (Envelope-1): -

- i. Original Earnest Money Deposit (EMD) (as per Sr. No.12).
- ii. The firm shall submit PAN/VAT/Registration certificate
- iii. Supporting Documents in substantiation of the ‘Minimum Qualifying requirements’ (as per Sr. No. 2 of NIQ)
- iv. Duly filled in & signed ‘Form of declaration’ as per Annexure-D.
- v. Bank Account Details as per Annexure-E.
- vi. Undertaking regarding Declaration of Eligibility as per Annexure-F.

PART-II (Envelope-2): -

Price bid: - Comprising of Price Bid at Annexure-A i.e., duly filled, signed and stamped in Bill of Quantities (BOQ).

4. Opening of Bid: -

The bid shall be opened in the following sequence: -

- i. First, the envelope Part-I shall be opened.
- ii. Part –II (Price Bid) shall be opened subsequently, if no clarification is required from the Bidder(s). In case clarification is sought from the Bidder(s), separate notification shall be displayed on web portals <http://sjvn.nic.in/tender.htm> & <http://www.sapdc.com.np/pages/tender> for opening of Price Bid(s) of responsive bidder(s).

5. No material and T&P will be issued by SAPDC.

6. Period of Contract:

The Contract shall be for a period of 2 years to be reckoned from date of issuance of Letter of Acceptance (LOA).

The Contract period may be extended on the same terms and conditions for a period of another 01 (One) year subject to satisfactory performance certification by OIC.

7. Allowable time for Servicing & for Delivery of items:

- a) Schedule Visit for servicing of AC as per scope of work shall be attended by the Contractor within 7th day of issuance of LOA or as intimation by SAPDC on half yearly basis (4 times during the performance of contract).
- b) Emergency Visit, if any, for emergency breakdown of AC shall be attended by the Contractor within 48 hours from intimation by SAPDC for free of cost (4 times during the performance of contract).

- c) Further, if SAPDC raised requirement only for the supply of Spare Parts of ACs, then the delivery of items shall also be made within 7 days from the date of requirement raised by SAPDC.
8. **Bid Validity:** The bid (s) shall be valid for 90 days from the opening of bid(s).
9. **Prices:** - The supplier/bidder shall offer rates & prices “on Firm Price Basis”. The quoted rates under **Annexure-A ‘BOQ’** shall be inclusive of transportation charges excluding VAT. VAT shall be paid extra by SAPDC as applicable on submission of documentary evidence.
- No payment on account of travelling, Boarding & lodging will be provided by SAPDC. Any other spare required during maintenance / urgency of the contract shall be paid by SAPDC extra. However, no labour payment or visit charges shall be borne by SAPDC. Annexure-A.
10. SAPDC reserves the right to adjust arithmetical or other errors (if any) noticed in the quotation as follows:
- Where there is a discrepancy between unit rate in figures and in words, the unit rate in words will govern; and
 - Where there is a discrepancy between the unit rate and the line item total resulting from multiplying the unit rate by the quantity, the unit rate as quoted in words will govern.
- In case error due to wrong extension of quantities, the quantities as specified in the NIT/NIQ will be considered and multiplied by the unit rates quoted in words to obtain the amount.
- The amount stated in the Bid will be adjusted by the SAPDC in accordance with the above procedure for the correction of errors and shall be considered as binding upon the bidder. If the bidder does not accept the corrected amount of bid, his bid will be rejected.
11. **Payment:** The payments will be made in the following manner:
- The Contractor shall raise the invoice after completion of each AMC visit along with field service report. The service report shall clearly indicate the service activities and consumable spare parts used, which shall be duly signed by the contractor & SAPDC. The payment (100%) shall be made within 45 days after submission of complete invoice.
 - 100% payment against the supply of spares parts (as on required basis) shall be made after receipt of material at the SAPDC store Tumlingtar if any. The payment shall be made within 45 days after the submission of complete invoice.
12. **Earnest Money Deposit (EMD):**
- EMD amounting to **NPR 20,100/-** shall be required to be submitted with the proposal in either of the form:
 - FDR (issued by a “A” Class Nepalese Bank) duly pledged in favor of **SJVN Arun-3 Power Development Company Pvt. Ltd.**
Or
 - Bank Draft (in original)/Manager’s cheque (in original) (issued by a “A” Class Nepalese Bank shall only be acceptable) in favor of **SAPDC-NPR Construction Account** payable at Khandbari, Nepal.
Or

Bank Guarantee (in original) in favor of SJVN Arun-3 Power Development Company Pvt. Ltd. (SAPDC) Acceptable to SAPDC for an amount as mentioned herein-above.

Earnest Money Deposit shall remain valid for **135 days** from the last date of submission of bids as stated in the invitation to bid. Bank Guarantee may be in the format provided in tender document **(Annexure-I)**.

Bidders are advised and shall be responsible to ensure the receipt of net amount (excluding bank transfer charges) in above account before last date of submission of bids.

However, if Bidder/Firm opt for submission of Earnest Money Deposited (EMD)/Bid Security directly in the bank account of SAPDC, then the documentary evidence/ proof of same (swift statement/ transfer statement/ account statement) has to be submitted along with technical bid in Part-I.

Any bid not accompanied by an acceptable Earnest Money Deposit shall be declared non-responsive and outrightly rejected by the Employer and their Part-II (Price Bid) bid shall not be opened.

- b. EMD of the bidder shall be forfeited, if the bidder withdraws or amends its bid or impairs or derogates from the bid in any respect within the period of validity of the bid.
- c. EMD of the bidder(s) shall be forfeited, in the event of non-compliance of Supply Order/Letter of Acceptance (LOA) by the successful bidder(s)/supplier(s).
- d. The EMD of unsuccessful Firm(s)/Agency(ies) shall be released within 30 days without any interest after declaration of non-responsive. Further, EMD of responsive bidders (other than L1 bidder) shall be released within 30 days without any interest after the issuance of Letter of Acceptance of successful Firm(s)/Agency(ies).
- e. The Earnest Money of the successful bidder shall be released within 28 days after the issuance of Letter of Acceptance without any interest subject to furnishing of requisite Performance Security in accordance to Sr. No. 15 of this NIQ
- f. No interest shall be payable by SAPDC on EMD.

13. Award Criteria:

- (i) The bid shall be evaluated on overall basis and the award shall be made based on the lowest rate/Amount quoted by the Bidder/Supplier for whole work/assignment as per **Annexure-A** in the Bill of Quantities.

- (ii) If, Bidder(s) quote Zero/Nil/left Blank/(-) rate(s) against any item(s) of BOQ then it will be presumed that bidder(s) has/have quoted the rate(s) for that item(s) in any other item(s) of BOQ. In that case Zero (0) rate(s) shall be considered for the purpose for evaluation as well as award.
14. **Liquidated Damages (LD):** In case of delay in Service/Supply of spare parts (if required any), LD @ 0.33% of contract price per week from 8th day of date of intimation by SAPDC shall be levied subject to maximum of 5% of the contract price (in terms of clause at Sr.No.14 & at Sr.No.18). Further, SAPDC reserves the right to terminate the contract after occurrence of 4 such events without serving any prior notice to firm/agency.
15. **Performance Security Deposit:**
- 15.1 Within 28 (twenty-eight) days from the date of issue of the Letter of Acceptance (LOA), the successful bidder(s) shall deliver to the Employer a Performance Security equal to **5% (Five percent)** of the Contract Price valid till 60 days beyond the contract completion period.
- 15.2 The Performance Security Deposit shall be in the form of a demand draft / Banker Cheque in favor of “**SAPDC-NPR Construction Account**” payable at Khandbari, FDR (duly pledged in favor of **SJVN Arun-3 Power Development Company Private Limited (SAPDC)**) The bidder may submit the same in the form of irrevocable, valid and fully enforceable Bank Guarantee in favor of **SJVN Arun-3 Power Development Company Private Limited (SAPDC)** in the prescribed form from a Class ‘A’ bank situated in Nepal acceptable to SJVN Arun-3 Power Development Company Private Limited.
- 15.3 Failure of the successful Bidder to comply with the requirements of Clause 15.1 shall constitute sufficient grounds for cancellation of the award and forfeiture of the Earnest Money Deposit. He will also be debarred from participating in bids invited by the Project for one year.
- 15.4 The performance guarantee will be returned by the EIC (Engineer-in-Charge) without any interest to the contractor within 28 days after completion of contract period.
- 15.5 In case of delay in submission of performance security beyond 28 days as provided in clause 15.1 above, interest @ SBI, India one year MCLR +200 Basis points applicable on the date of bid submission shall be charged on per day basis up to the date of delay in submission. However, delayed acceptance beyond 56 days shall be at the sole discretion of SAPDC and Letter of Acceptance/ award (LOA) shall be subject to cancellation and forfeiture of EMD along with other suitable action as per NIQ.
- 15.6 In case, the last day of submission of Performance Security happens to be a bank holiday, the last day of submission shall be the next working day.
- 15.7 **The notification of Award (NOA)/Letter of Acceptance (LOA) will constitute the formation of the Contract and further subject only to the furnishing of a performance security.**
16. **Force Majeure:** The term "Force Majeure" shall herein mean riots (other than among the Vendor's employees), Civil Commotion (to the extent not insurable), war (whether declared or not), invasion, act of foreign enemies, hostilities, civil war, rebellion, revolution, insurrection, military or usurped power, damage from aircraft, nuclear fission, acts of God, such as earthquake (above 7 magnitude on Richter Scale),

lightning, unprecedented floods, fires not caused by Vendor's negligence and other such causes over which the Vendor has no control and are accepted as such by the Engineer-in-Charge (EIC), whose decision shall be final and binding. In the event of either party being rendered unable by Force Majeure to perform any obligation required to be performed by them under this contract, the relative obligation of the party affected by such Force Majeure shall be treated as suspended for the period during which such Force Majeure cause lasts, provided the party alleging that it has been rendered unable as aforesaid, thereby shall notify within 10 days of the alleged beginning and ending thereof giving full particulars and satisfactory evidence in support of such cause.

Extension of time without levy of LD shall be provided during the period of occurrence of Force Majeure event, however no cost compensation shall be provided.

17. **Packing:** The supplier, wherever applicable shall properly pack and stack all materials/goods in such a manner as to protect them from deterioration and damage during transportation. The supplier shall be responsible for all damage due to improper packing.
18. **Replacement:** If the material/goods or any portion thereof is damaged or lost during transit, SAPDC shall give notice to the supplier setting forth particulars of such material/goods damaged or lost during transit. The replacement of such material/goods shall be effected by the supplier within 7 days (reckoned from the date of notice given by SAPDC to the supplier), to avoid unnecessary delay in the intended usage of the materials free of cost to the SAPDC.

Further, if replacement shall not be made within the above said time, then the additional LD @ 0.33% of contract price per week of delay shall be levied.

The levied LD shall be subject to maximum of 5% of the contract price in terms of clause at Sr.No.14 & at Sr.No.18)
19. **Rejection:** In the event that any of the material/goods supplied by the supplier is found defective in material or workmanship or otherwise not in conformity with the specification, SAPDC shall either reject the material/good(s)/Item(s) or request the supplier in writing to rectify/replace the same. The supplier, on receipt of such notification shall rectify/replace (As directed by the OIC/EIC) the defective material/good(s)/item(s) free of cost to the SAPDC. Decision of OIC/EIC (SAPDC) shall be final and binding on the supplier(s).
20. **Demurrage, Wharfage etc.:** All demurrage, wharfage and other expenses incurred due to delayed clearance of the material/goods or any other reason shall be on the account of the supplier.
21. **Guarantee/Warranty:** Guarantee/Warranty shall be minimum for 12 months or as per the Policy of Original Equipment Manufacturer (OEM), whichever is higher (as applicable to respective item(s) of BOQ). In case of any complaint/repair required during Warranty/Guarantee period, the vendor/ supplier will respond within two days and ensure rectification within one week's time from the date of lodging of complaint. The supplier shall either rectify or replace the defective material/goods free of cost to SAPDC.
22. **Consignee:** The material/ goods under this Contract shall be dispatched to the location as mentioned in the BOQ/Scope of Work.

However, Chief Engineer (Store) shall be the consignee for this contract and payment and other codal formalities shall be done through Chief Engineer (Store) for all the material. The address of consignee shall be as following:

23. **Inspection:** Inspection of the item(s)/material shall be carried out by EIC or his authorized representative at Store/ locations as mentioned in the BOQ/Scope of Work. EIC shall ensure the technical specification(s), make/brand/model (If applicable) of the supplied item(s) is/are as per NIQ/LOA.

24. **Insurance:** -

The successful firm/agency (i.e., to whom the work will be awarded) shall take out and maintain, and shall cause any associated person (s)/manpower to take out and maintain, at its (or the associated person s', as the case may be) own cost but on terms and conditions approved by SAPDC, insurance against the risks, and for the coverage, as stipulated in the contract or any applicable law including Labour Law of the land (in Nepal), and as per SAPDC's Officer-in-charge (OIC) instructions , shall provide evidence to SAPDC showing that such insurance has been taken out and maintained and that the current premiums have been paid. The agency/firm shall ensure that such insurances are in place before commencing the Services from effective date of commencement of AMC. Alterations to the terms of insurance shall not be made without the approval of the Officer-in-charge, SAPDC.

25. **Extension of Time:** -

Time for completion of services is defined under Clause 7, however, if there is any delay/causes, which in the opinion of bidder is beyond his/her control, in that case, such events shall be brought out in the notice of SAPDC by the bidder in writing within 07 days of occurrence of event.

Upon receiving request from bidder, Engineer-in-Charge of work may give a fair and reasonable extension of time for completion, after taking into consideration the nature of the work delay and practicability of its execution during the period of extension.

Provided further that no monetary claims shall be admissible to the bidder for such extension of times.

26. **Resolution of Dispute:** In case of any dispute or difference that arises out of the subject cited supply, the same shall be referred to the Sole Arbitrator, who shall be appointed by the CEO, Arun-3 HEP, SAPDC, Tumlingtar. The award of the arbitrator shall be final and binding on both the parties.

Courts of Chainpur (Nepal) shall have exclusive Jurisdiction for adjudication upon the dispute arising out of the subject cited supply between the parties.

31. **General Information:**

Access to Project Sites:

To reach the site of Arun-3 HPP Nepal the nearest broad-gauge railway station is Jogbani, Bihar (India) and further by road up to Tumlingtar is about nearly 264 Km. Jogbani in Bihar is a city of India with Nepal border and is just 6.00 Km. from Biratnagar (a major industrial town of Nepal).

Road conditions in different road segment en-route are as under:

- Jogbani to Hile: - Hile is located at a distance of 118 Km from Jogbani and the existing road up to Hile is black topped road and in good condition. Hile is at EL 1920 m from sea level.
- Hile to Tumlingtar (Hill road route): - This route is about 111 Km and the road partially is black topped and kuchhaup to Chainpur (EL 1285m) and Chainpur to Tumlingtar is black top.
- Tumlingtar is also connected to Kathmandu by air by around thirty-five minutes' journey.
